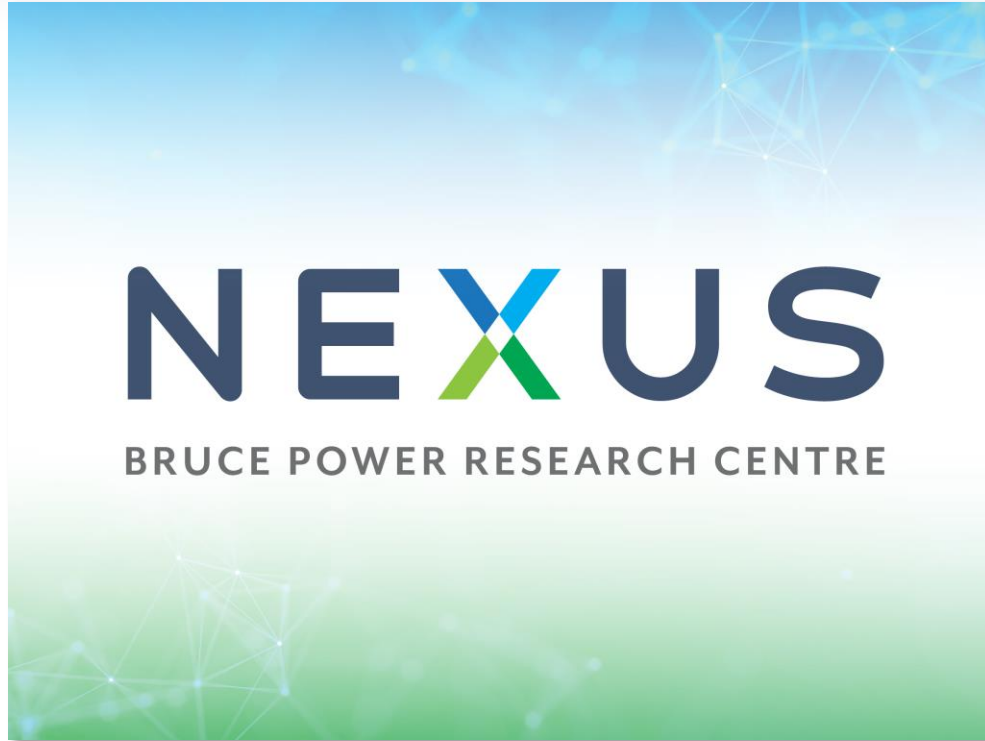

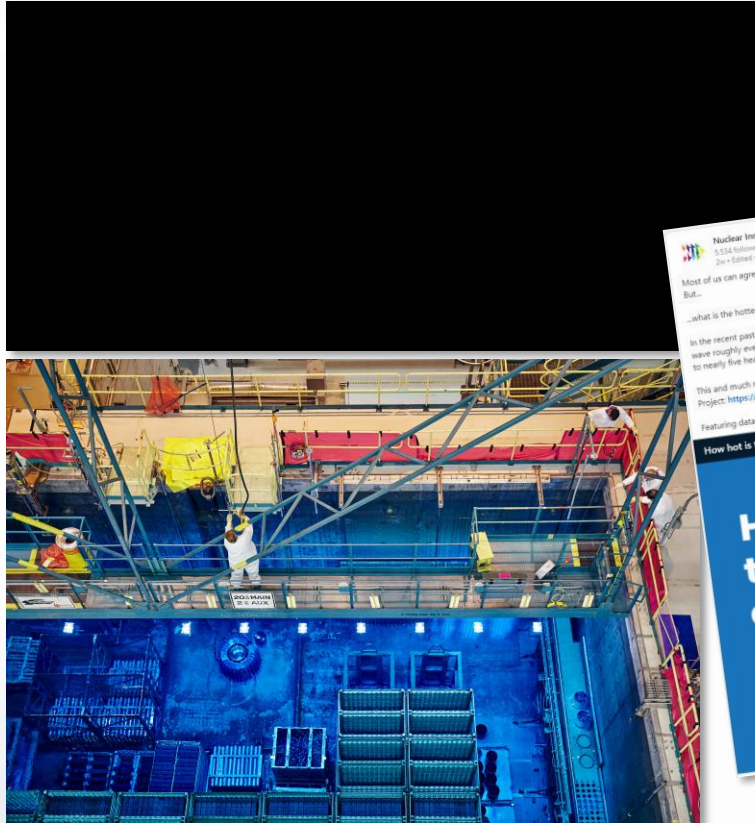

Town of Saugeen Shores + NII deliverables

Background

In 2023, NII and the Town of Saugeen Shores began negotiations to renew the lease NII currently holds for 620 Tomlinson Drive. As part of those negotiations, NII and the Town agreed to a five (5) year lease with specific deliverables.

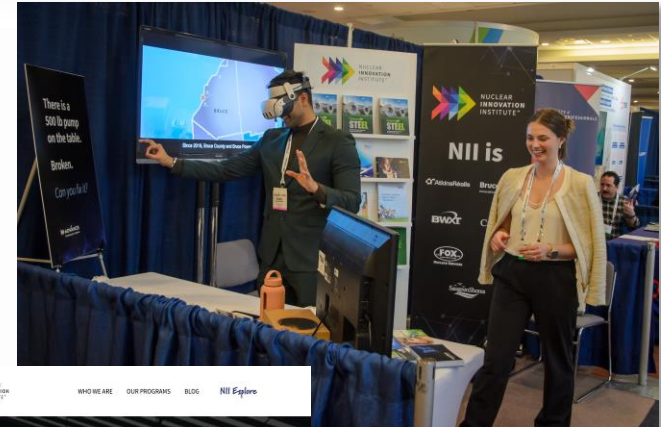
Over the 2024 calendar year, NII has provided Members of Council a quarterly report with the status and updates on the deliverables outlined in the lease.

Deliverables

Item	Deliverable description
3.1.1	Maintain its head office in the Town for the Term of the Lease
3.1.2	Make space available to the Town for Council and Committee meetings and other meeting needs upon request according to the conditions set out in section 3. (c) of the Lease.
3.1.3	NII Board shall appoint a representative from the Council for the Town to fill a member- at-large seat on the NII Board of Directors within the parameters of its by-laws.
3.1.4	The Town will receive brand recognition, similar to, that of other Founding Members at NII events and in NII's publications and on NII's website.
3.1.5	The Town's Board representative will be invited to all Board activities and events such as meeting with visiting delegations, participating in NII special events, wherever they occur, and joining NII-led policy and advocacy initiatives
3.1.6 A	Share clean energy advocacy content including social media posts with the Town's communications department.
3.1.6 B	Include Town elected officials and staff in relevant NII public and industry events, including meetups and workshops.
3.1.6 C	Pass any inquiries about local investment opportunities to the Saugeen Shores Economic Development Officer.
3.1.6 D	Connect the Town to external innovation entities that could be of value to the Town.
3.1.7	Provide the Town with the same opportunity as Founding Members to bring innovation project ideas forward to NII to evaluate and execute.

To date, NII has provided the following to the Town:

- ▶ Recognized the Town as a Founder throughout its materials
- ▶ NII HQ has hosted Council meetings for the last several months
- ▶ Mayor Luke Charbonneau was appointed to NII Board of Directors

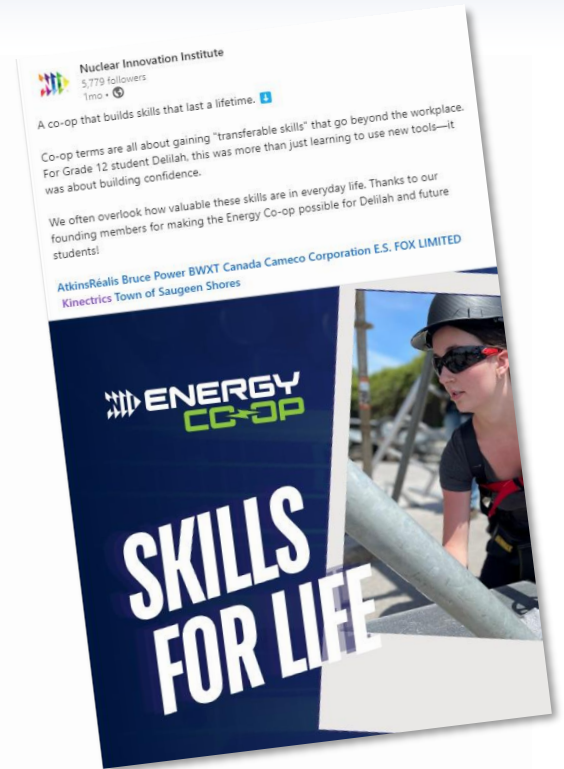
