## The proposal

A change is proposed, and we're asking for your input. The purpose is to redesignate a portion of the property from Agricultural Areas to Agricultural Areas with Exceptions to permit a concrete manufacturing plant with outdoor storage, parking and a stormwater management pond, and a future polyvinyl chloride (PVC) extrusion manufacturing facility. The application will facilitate a partial relocation and expansion of Carson's Supply, a commercial business located in Port Elgin. The related Zoning By-law Amendment file is Z-2023-056 which is proposed to rezone that same area from Agricultural (A) to Agricultural Commercial Special (AC2-x) and Open Space (OS) to facilitate the proposed use.

# A by-law to adopt Amendment Number C-2023-004 (Carson) to the County of Bruce Official Plan

Authority is provided in Sections 17 and 21 of the Planning Act, R.S.O. 1990, as amended.

The Council for the Corporation of the County of Bruce enacts as follows:

- 1. Amendment Number C-2023-004 to the County of Bruce Official Plan attached and forming part of this by-law is approved.
- 2. That this By-law come into force and take effect on the day of the final passing thereof, subject to the provisions of the Planning Act, R.S.O. 1990, as amended.

#### Part B - The Amendment

#### **Introductory Statement**

All of this part of the document entitled "Part B - The Amendment" and consisting of the following text, and attached map designated as Schedule 'A', constitutes Amendment Number C-2023-004 to the Bruce County Official Plan.

The Official Plan Amendment amends a portion of the Agricultural Areas designation of the County Official Plan to permit a non-agricultural use in a prime agricultural area. The proposed use is industrial in the form of a concrete manufacturing and precast concrete facility and a polyvinyl chloride (PVC) injection and extrusion manufacturing facility, with outdoor storage, a parking area and a stormwater management pond.


#### The Amendment

Schedule A: Land Use is amended by adding the following reference to a
portion of the lands at SAUGEEN CON 12 LOTS 10 AND;11 PLAN 154 PT LOTS K
AND L (Saugeen Township), Town of Saugeen Shores, as shown on the attached
Schedule 'A':

'Section 5.5.13.110'

2. The Bruce County Official Plan is amended by adding the following subsection to Section 5.5.13 - Exceptions - Agricultural Areas:

"2128080 Ontario Inc. c/o Cobide Engineering Inc. (C-2023-004)
Notwithstanding the policies of Section 5.5.4 [Permitted Uses Agricultural Areas] of this Plan, on the lands subject to Site Specific
Policy Area 5.5.13.110 at SAUGEEN CON 12 LOTS 10 AND;11 PLAN 154 PT
LOTS K AND L (Saugeen Township), Town of Saugeen Shores, a concrete
manufacturing and pre-cast concrete facility and a polyvinyl chloride
(PVC) injection and extrusion manufacturing facility, with outdoor
storage, a parking area and a stormwater management pond, shall also
be permitted uses. The site-specific zoning and site plan control shall
outline the area where the industrial use, outdoor storage, and
stormwater management pond are permitted, and shall identify
minimum separation distances to sensitive land uses and other measures
to avoid, minimize or mitigate any potential adverse effects from odour,
noise, dust, light, vibration and/or other contaminants on adjacent land
uses which shall include visual screening."
