Personnel

1. Chief's Commendation

Their decisive intervention assisted in saving a life and exemplifies the highest standards of bravery, compassion, and public service. Their heroic actions reflect great credit upon yourself and serve as an inspiration to all. 2. Member Spotlight – Constable Drost

As noted in the Saugeen Shores Police Service 2023-2025 Strategic Plan, Chief Zettel highlighted new Constable Drost. 1. NICHE UA Training
